

Nioqutissat eqqussat akileraarutegarritaaneri akitsuutegarritsinerlu pillugit Kalaallit Nunaanni aalajangersakkat

Angalassut Kalaallit Nunaannut tikinnermini aallalerer-
mimmilluunniit Kangerlussuarmi, Narsarsuarmi, Kulussu-
milu nioqutissanik akitsuutegarngitsunik pisinissamin-
nut periarfissagarput.

Nioqutissanik akitsuutegarngitsunik Kalaallit Nunaan-
nut eqqussineq taamaallaat pisinavaoq angalassup nu-
nanit allaniit, taamatuttaaq Danmark-imiit aammalu
Savalimmiuniit, tikinnermini nioqutissanik nassarrera-
tigut pisineratigulluunniit.

Nioqutissat akitsuusernegangitsut katillugit ima amerlatigisut eqqunegarinnaaupput:

- 1) Sikaritsit 200-t, **imaluunniit** Sikaat 50-t, **imaluunniit** Cigarillosit 100-t, **imaluunniit** Tupat 250 g, **imaluunniit** Sukuluut snusilluunniit 250 g,
- 2) Sikaritsinut imusivissat **imaluunniit** pappiaratas-
sat immeraannaat 200-t.
- 3) Imigassaq kimitooq (22 pct. sinnerlugu aalakoornartortalik) 1 literi **imaluunniit** hevviini (15-p 22 pct.-illu akornani aalakoornartortalik) 2 literi.
- 4) Viinni heriseq (15 pct. inorlugu aalakoornartortalik) 2,25 literi.
- 5) Immiaaqqat 2 literi.
- 6) Imnerusaatit kulysretallit **imaluunniit** imigassat koffeinretallit koffeinimik literimut 149 mg-imit anginerusumik akullit 2 literi.
- 7) Imeq 1 literi.
- 8) Tipigissaat 50 g aamma 0,25 literi tipigissaoq.
- 9) Pinnerusaatit tipigissullu allat katillugit amnerpaamik 1.000 koruunit nalingannut.
- 10) Sukkulaatit mamakujuttunilu nioqutissiat katillugit 4 kg.
- 11) Kaffit aamma tit katillugit 4 kg.
- 12) Negi, negiit nioqutissiat aamma timmissat katillugit 5 kg.

- Inuit 18-inik ukioqalereersimasut kisimik tupanik nioqutissanik, immiaaqqanik, viinninik imigassanillu kimittuunik akitsuutegarngitsunik eqqussisinnaaqput.
- Nioqutissat pisinarinegarsimasut takunegarinnaaq-sunnorlugit pisisumit namminermit nassarneqassapput.
- Aalajangersakkanik atuuttunik unioqutisineq akiliisitsinermik pillaatissiissutaasinaavoq.

Grønlandske told- og afgiftsbestemmelser

Rejsende har mulighed for både ved indrejse til og udrejse fra Grønland at indkøbe afgiftsfri varer i lufthavnen i Kangerlussuaq, Narsarsuaq og Kulusuk.

Afgiftsfri indførsel af varer til Grønland kan kun ske ved at den rejsende medbringer eller indkøber varerne ved indreisen til Grønland fra udlandet, herunder Danmark og Færøerne.

Samlet kan der afgiftsfrit indføres følgende mængder:

- 1) 200 cigaretter, eller 50 cigarer, eller 100 cigarillos, eller 250 g røgtobak, eller 250 g skrå- eller snustobak.
 - 2) 200 stk. cigarettepapir eller cigarethylistre.
 - 3) 1 liter spiritus med en alkoholvolumenprocent på over 22 eller 2 liter hedvin med en alkoholvolumenprocent mellem 15-22.
 - 4) 2,25 liter bordvin med en alkoholvolumenprocent på under 15
 - 5) 2 liter øl.
 - 6) 2 liter kulsvreholdige læskedrikke eller koffeinholdige drikkevarer med et koffeinindhold på mere end 149 mg pr. liter
 - 7) 1 liter drikkevand
 - 8) 50 g parfume og 0,25 liter toiletvand.
 - 9) Kosmetik og andre toiletmidler til en samlet maksimal værdi af kr. 1.000.
 - 10) 4 kg i alt af chokolade- og slikvarer.
 - 11) 4 kg i alt af kaffe og te.
 - 12) 5 kg i alt af kød, kødvarer og fjerkræ.
- Afgiftsfri indførsel af tobaksvarer, øl, vin og spiritus kan kun foretages af personer, der er fyldt 18 år.
 - Indkøbte varer skal medbringes personligt og synligt.
 - Ved overtrædelse af gældende bestemmelser, kan der idømmes bøder.

Greenland customs and duty regulations

Travellers arriving in Greenland and departing from Greenland may purchase duty-free goods at the airports in Kangerlussuaq, Narsarsuaq and Kulusuk.

Duty-free import of goods to Greenland may only take place, if the traveller brings or purchases the goods when arriving in Greenland from abroad, including Denmark and the Faroe Islands.

Duty-free import only includes the following total quantities:

- 1) 200 cigarettes, or 50 cigars, or 100 cigarillos, or 250 g smoking tobacco or 250 g screw or snuff.
 - 2) 200 sheets of cigarette paper or cigarette wrappers.
 - 3) 1 liter of spirits (over 22 alcohol volume) or 2 liters of fortified wine (15-22 alcohol volume)
 - 4) 2,25 liter wine (less than 15 percent alcohol volume)
 - 5) 2 liters of beer
 - 6) 2 liters of carbonated beverages or other beverages contents of koffein more than 149 mg per. liter
 - 7) 1 liter of drink water
 - 8) 50 g perfume and 250 ml of eau de toilette.
 - 9) In addition, cosmetics and other toilet articles up to a total value of DKK 1,000.
 - 10) Up to 4 kilo of chocolate and sweets.
 - 11) Up to 4 kilo of coffee or tea.
 - 12) 5 kilos of or meat, meat products, or poultry.
- Duty-free tobacco products, beer, wine and spirits may only be imported by persons over 18 years of age.
 - Durable goods must be carried personally and visibly.
 - Offenders of present regulations are liable for fines.
